Meeting of the Richmond Public Library (RPL) Library Board of Trustees (LBOT) was called to order by Vice Chairman William Yates at 11:38 a.m. at the Main Library located at 101 E. Franklin Street, Richmond, Virginia 23219. A quorum was present.

Finance  Daisy Weaver Christine Peterson Scott Firestine	Ms. Peterson gave an overview of the Budget. She stated the City was going to change to a performance-based budget instead of a zero-based budget as in the past. FY2020 Budget is \$6.3 million. Projecting an increase for FY2021 to \$6.7. Requesting more funds for books and materials, as well as funding for unfunded vacant positions.
	Mr. Lydiard asked if there could be an indicator, next to the Encumbered and questioned accounts on the Operations Budget.
Facilities  Scott Firestine	<ul> <li>Capital Improvement Projects (CIP) is a separate budget from the Operations and Personnel Budget. Mr. Firestine gave a brief history on the two projects that have been requested for several years.</li> <li>500231 Library Projects (Maintenance)–Addresses the HVAC Replacement in the Special Collections area, Roofs of Branch Libraries, and a construction project at Main improving the first floor Children's restrooms by converting them into public restrooms. This will also address any security concerns. Going forward in 2021-2025, the focus will be on security and surveillance, as well as furnishings at all Library locations.</li> <li>273500 – Funding that will pay for the Master Plan.</li> </ul>
Governance  David Lydiard	Mr. Lydiard mentioned that Ms. Francis has not been to a meeting since March 27, 2019. He has discussed with her about sending in a letter of resignation, but has not received any correspondence to date. The Chair sent City Council a letter requesting Ms. Francis be removed from the LBOT due to not complying with its By-Laws.  The search for a member with facilities experience to fill the vacant seat on the LBOT is ongoing. Mr. Lydiard mentioned he received some interested responses, but they are from individuals that do not live within the City limits. Ms. Peterson said she did know someone who was interested and will send Mr. Lydiard the contact information.

#### **UNFINISHED BUSINESS**

• E-Book Action on Macmillan Publishers – After discussion, the LBOT members were in agreement to boycott on e-books that have restrictions from Macmillan Publishers. Ms. Peterson moved that the Richmond Public Library Board of Trustees propose to boycott Macmillan Publishers' digital encumbered offerings for the foreseeable future and direct the Library Director to draft a statement to Macmillan and a statement to our patrons.

- Strategic Plan Mr. Yates recommended to table further discussions and vote of approval to the January 22, 2020 meeting. The LBOT members were in agreement.

**Hiring Update:** Interviewing for vacant positions is ongoing. Currently RPL has over 15 FTE vacancies. This is a significant problem and is necessitating that we utilize temporary workers and overtime due to the long delays and inefficiencies of the City Human Resources Department.

**RFP for the Integrate Library System (ILS on-line catalog) Update:** Migration of the Library's catalog to an SAAS solution for improved search, database control, and maintenance to begin mid-January 2020.

**RFP for the Main Library Facilities Master Plan Update:** In process by Department of Procurement Services (DPS) and Legal. We await a signed contract to begin work.

**Access RVA Comcast Channel Update**: The Public Television station project is ongoing. Equipment is very dated. Library staff is learning from the volunteers and continuing with the process established by Comcast until a revised policy and procedure can be developed. We are reallocating a position to oversee the operations of the program. Interviewing and hiring will be done by the end of February 2020.

**1st Floor Restroom Renovation Update:** Construction continues of new toilet rooms on the first floor at the Main Library. Internal demolition of walls, fixtures, and flooring is mostly complete. Boring of slab to begin mid-January to prepare for new plumbing runs.

**Macmillan Publishing Update:** RPL is boycotting e-books from Macmillan Publishing with embargo restrictions. We have not purchased e-books with that restriction since November 1, 2019, when the embargo went into effect.

**Special Funds Audit:** Met with the City Auditors on January 6, 2020, to discuss the start of the Special Funds Audit. The Auditors are very eager to help RPL find balance of all the Special Fund accounts including the Law Library revenue.

**Eviction Exhibit:** Met with Human Services DCAO Regional Gordon and Library Board Member Christine Peterson on December 11, 2019, to discuss the Eviction Exhibit that will be held at the Main Library. RPL will hold an exhibit with HOME for Eviction in January 2020. This will be part of the VCU Common Book 2019 topic. We wish to engage the community and the Mayor's Eviction Task force around this topic.

**RPL Mascot Ripple:** Ripple's special story time is held annually in December. Ripple visited all locations to spread holiday cheer during story times at all locations the first and second week of December.

**Floating Collections Trial**: Floating is a tool libraries began using over 15 years ago to increase efficiencies, reduce delivery times, improve holds turnover, disperse items and titles, and freshen collections in locations. Starting in January 2020, we began floating audiobooks and large print items to better share our collections, leverage the capacity of the library system, reduce items in transit, and improve variety at all locations. We wanted to test it and see if it will be a system that will improve collections for our patrons.

**3D Printer-Main Library:** The 3D Printer located in the Innovation Lab is now available for public printing. Previously, people could only print projects made in one of our Innovation Lab classes. However, now the public can use it for their own designs. They will need to complete an orientation and submit their designs for approval via the website before being appointed a time for printing. We offer orientations in the Innovation Lab on the 2nd Saturday of each month. We will add a video training in the future.

The Richmond Public Library system exists to serve many needs of Richmond's diverse population.

The libraries of today are significantly different than the ones I used while growing up in Richmond.

We have excellent internet access, electronic card catalogs, 3D printers and "maker spaces," comfortable chairs, a higher noise level, librarians who help not only with research but also with resumes, innovative youth programs, etc. But at the core, libraries are about books, knowledge and thought.

It is distressing to learn that Macmillan Co., a leader in U.S. publishing, has decided to "throttle" public libraries' access to some e-books. Specifically, they are restricting the ability of libraries to purchase multiple copies of many popular e-books at the time of publication.

Apparently, Macmillan is doing this to encourage avid readers to purchase books rather than borrow them from the library.

By creating an artificially long wait period for library patrons to access e-books Macmillan hopes that readers, at least those with comfortable budgets, will give up on the library and buy their own copies.

The RPL Board of Trustees strongly objects to this assault on the free library and, particularly, those patrons with little disposable income to spend on purchasing books.

Rather than agree to Macmillan's limiting of our purchasing e-books, we have decided to suspend the purchasing of these titles in the e-book format.

In order to minimize inconvenience to our patrons, RPL will increase our purchase of printed copies of these popular titles. We value all of our community members and look forward to serving everyone.

# Update on Macmillan Ebook Embargo Libraries find allies in Congress, communities

wo months have passed since Macmillan Publishing began its restrictive embargo on ebooks, and the response by library advocates, by way of a public awareness campaign and efforts to influence state and federal lawmakers, appears to be gaining steam.

More than 230,000 people have signed the #eBooksForAll online petition

(<a href="https://cbooksforall.org/">https://cbooksforall.org/</a>) urging Macmillan to reverse its decision to limit a single copy per title to each public library for the first two months after its release. And advocates are making inroads at the congressional level—particularly with the <a href="https://commercial.and/">https://commercial.and/</a> Administrative law.

(https://americanlibrariesmagazine.org/blogs/the-scoop/new-ala-report-cites-abusive-pricing-denial-delay-sales-libraries-major-publishers/) which is currently investigating competition in digital markets.

"When we launched this public effort in September, we had slightly modest expectations," American Library Association (ALA) President Wanda Kay Brown said during a <u>December 17</u> <u>Public Library Association (PLA) webinar</u>,

(http://www.ala.org/pla/education/onlinelearning/webinars/ondemand/ebooksupdate) updating members on the progress of the #eBooksForAll campaign. "However, because of the help from libraries across the country, we have been blown away by the results."

ALA also has established a working group, approved during the 2019 Annual Conference in June, which tasks its 15 members with exploring options to improve digital access to the public.

Alan S. Inouye, ALA senior director of public policy and government relations, said ALA is taking a fourfold approach in its effort to reverse Macmillan's decision: the #eBooksForAll campaign; direct engagement with the industry; and intervention at both the federal and state levels. Outreach to members of Congress in August and early September resulted in the House Judiciary Subcommittee on Antitrust, Commercial, and Administrative Law asking advocates to provide input on the matter for its investigation into competition in digital markets, Inouye said.

Meanwhile, libraries continue with their move to discontinue purchasing ebooks from Macmillan altogether. King County (Wash.) Library System Executive Director Lisa Rosenblum said her system is the largest lender of ebooks in the country and spends nearly half a million dollars annually on Macmillan ebooks.

"Why are they dictating when we work so well with them?" she said during the December 17 webinar. "We helped build their brand of ebooks. We've worked for years to make downloading of digital seamless, and now, all of a sudden, we've turned into the enemy. Rosenblum said library advocates there also recently contacted US Rep. Pramila Jayapal (D-Wash.), who serves on the House Judiciary Subcommittee and represents King County. Jayapal has since sent Macmillan a letter (https://ebooksforall.org/wp\_

content/uploads/2019/12/Congresswoman-Jayapal-Letter-to-Mamillan-Publishers12-06-19,pdf) expressing her disappointment in the embargo and has requested more information from the company, Rosenblum said.

She and other advocates in King County have also contacted the Washington State Attorney General's Office, noting that the office expressed antitrust concerns. They also joined Seattle Public Library in penning an op-ed in local newspapers.

In addition to the advocacy efforts, library administrators at King County and elsewhere have been providing information to patrons to explain their decision to discontinue buying ebooks from Macmillan.

Vailey Oehlke, director of libraries for Multnomah County (Oreg.) Library (MCL), placed a banner on MCL's OverDrive portal to explain the issue. She told American Libraries that MCL has received several emails from patrons who strongly support the move to stop buying from Macmillan. "One [patron] is disabled and on a fixed income and relies on ebooks but felt strongly that Macmillan is shirking its responsibility to the community," she said.

Kelvin Watson, director at Broward County (Fla.) Libraries, said his system has also stopped purchasing ebooks from Macmillan over its embargo. And patrons are beginning to notice. "In these instances, we are suggesting the customers check out a hardback copy of the book and explaining the purchasing restrictions that were put in place by Macmillan," he said in an email. "In response to this challenging situation created by the publisher, all we can do is make an effort to serve the customer as best we can."

What comes next is uncertain, but Macmillan CEO <u>John Sargent will be hosting an informal forum (https://www.eventscribe.com//2020/ALA-Midwinter/fsPopup.asp2</u>



Ramiro Salazar, PLA president and director of San Antonio Public Library, says Sargent has also requested the opportunity to speak at PLA's conference in Nashville in February, Salazar notes that the PLA board has not yet formally discussed the issue, and the request is pending.

## A MESSAGE FROM THE RICHMOND PUBLIC LIBRARY DIRECTOR - DRAFT

The Richmond Public is joining large library systems across the country and a majority of libraries in the Commonwealth of Virginia in suspending purchases of all electronic versions of Macmillan Publishers' new releases.

Macmillan has instituted an unfair practice, only applied to libraries, of restricting access to one copy of a title in the first eight weeks after publication. A single copy of a new title for a period of two months is not sufficient nor is it acceptable for our library patrons. In some instances, this embargo will force readers to wait a year or more to borrow an e-book.

Some might believe that an eight-week embargo is no less harmful than other restrictions we have accepted on e-books from publishers. At Richmond Public Library, we believe an embargo sets a troubling precedent that, if followed by others, would give publishers unprecedented control over basic access.

By controlling the number of newly released eBook copies that can be purchased, Macmillan is allowing only a certain segment of society to access digital content in a timely manner — those who can pay for it. This drastic inequality cannot stand. It opposes the core principle of your public library.

Among libraries participating in the boycott are the Columbus Metropolitan Library, the Nashville Public Library, the Maryland Digital Library, Washington State's King County Library System, Fairfax County, Loudoun County, and Chesterfield County.

Please join us in our fight for fair and equitable access to information.

# A MESSAGE FROM THE RICHMOND PUBLIC LIBRARY BOARD CHAIR - DRAFT

The Richmond Public Library system exists to serve many needs of Richmond's diverse population. The libraries of today are significantly different than the ones I used while growing up in Richmond.

We have excellent internet access, electronic card catalogs, 3D printers and "maker spaces," comfortable chairs, a higher noise level, and librarians who help not only with research but also with resumes, innovative youth programs, etc. But at the core, libraries are about books, knowledge, and thought.

It is distressing to learn that Macmillan Co., a leader in U.S. publishing, has decided to "throttle" public libraries' access to some e-books. Specifically, they are restricting the ability of libraries to purchase multiple copies of many popular e-books at the time of publication.

Apparently, Macmillan is doing this to encourage avid readers to purchase books rather than borrow them from the library.

By creating an artificially long wait period for library patrons to access e-books, Macmillan hopes that readers, at least those with comfortable budgets, will give up on the library and buy their own copies.

The RPL Board of Trustees strongly objects to this assault on the free library and, particularly, those patrons with little disposable income to spend on purchasing books. Rather than agree to Macmillan's limiting of our purchasing e-books, we have decided to suspend the purchasing of these titles in the e-book format.

In order to minimize inconvenience to our patrons, RPL will increase our purchase of printed copies of these popular titles. We value all of our community members and look forward to serving everyone.

## **Questions and Answers - DRAFT**

#### **HOW DOES THIS WORK?**

When the Library buys an eBook, we are actually purchasing a license. Each publishing house has its own price model. Many publishing houses use the 2-year licensing model. The price libraries pay for an eBook is not the same as it would be for a consumer. For example, the popular "Where the Crawdads Sing" by Delia Owens is about \$15 for a consumer to purchase. The library is charged \$55 for 24 months of usage. If the library still wishes to retain the title in eBook format, we will pay an additional \$55 for two more years of use.

#### EBOOKS AT RICHMOND PUBLIC LIBRARY

At Richmond Public Library, 11.5% of our circulation is from digital materials. Between FY2017 and FY2019, the access to e-content nearly doubled!

Digital technologies are becoming increasingly inseparable from the ways that people learn, work, and interact. The library's unique ability to create equitable access for information and knowledge is more important than ever. Needless to say, our city and community is strongest when all individuals have the same opportunity to further their personal, educational, and professional goals.

One of the great things about eBooks is that they are convenient, flexible, fast, and available from us even when the library closes. Users who are sight impaired can make them large-print books with only a few clicks, and most eBook readers offer fonts and line spacing that make reading easier for people who have dyslexia or other visual challenges. Because portable devices are light and easy to hold, eBooks are easier to use for some people who have physical disabilities. They are becoming a very popular way for people to access and consume information.

#### **Frequently Asked Questions**

- Why now?
  - O Discussions about the fairness of publishers' digital pricing and access for libraries have been ongoing for at least a decade [https://go-to-hellman.blogspot.com/2010/03/ebooks-in-libraries-thorny-problem-says.html]. However, the challenges for libraries intensified rapidly in 2018/2019 as publishers implemented drastic changes to their digital content pricing. Below is a timeline of changes to e-content lending models for libraries:
    - July 2018 Tor Books [https://www.ualibrary.org/mediasrvc/blog/statement-release-regarding-tor-digital-books] (also Tor/Forge or Thomas Doherty, a division of Macmillan Publishers) implements a four-month embargo on availability of new eBook title for libraries.

- October 2018 Penguin Random House [https://www.publishersweekly.com/pw/by-topic/industry-news/libraries/article/77904-penguin-random-house-changes-its-library-e-book-terms.html] ceases perpetual eBook licensing for libraries and implements a two-year metered model.
- July 2019 Hachette Book Group [https://www.publishersweekly.com/pw/by-topic/industry-news/libraries/article/80486-hachette-book-group-changes-library-e-book-terms.html] ceases perpetual eBook and eAudiobook licensing for libraries and implements a two-year metered model.
- July 2019 Blackstone Audio [http://www.readersfirst.org/news/2019/6/17/hachette-blackstone-change-library-digital-content-modelsavailability] imposes a 90-day embargo on new eAudiobook titles for libraries.
- August 2019 Simon & Schuster [https://the-digital-reader.com/2019/07/02/simon-schuster-changes-library-ebook-audiobook-license-terms/] ceases perpetual eAudiobook licensing for libraries and implements a two-year metered model.
- November 2019 (pending) Macmillan Publishers [https://goodereader.com/blog/digitallibrary-news/macmillan-is-going-to-embargo-all-ebooks-to-libraries-by-2-months] will implement a two-month embargo on all new eBook titles for libraries.

#### • Which eBooks are affected?

O All eBook titles published by Macmillan or by any of the publishers that Macmillan owns. These titles will still appear in our catalog in other formats, but will not be available in eBook format.

## • What will happen to Macmillan eBooks already in the library catalog?

o Macmillan eBooks already in our collection will remain. You may continue to place hold requests and check them out as usual. If you have a Macmillan eBook checked out right now, it will not be affected.

#### Does this purchase suspension include Macmillan books in all formats?

 No. This decision only affects Macmillan eBooks. RPL will continue to purchase print versions and not embargoed eBooks from Macmillan titles. We will revisit this decision and expand or contract based on future restrictions imposed by Macmillan.

#### • If I submit a purchase request for a new Macmillan eBook will it be rejected?

O Yes. We will not be purchasing any access restricted Macmillan eBooks. Library staff will process and consider purchase suggestions for all other Macmillan formats as usual.

## • I do not know much about Macmillan. What books do they publish?

- Macmillan is one of the "Big Five" book publishers in the world, along with Hachette Book Group, HarperCollins, Penguin Random House, and Simon & Schuster. They publish a wide variety of fiction, nonfiction, and other genres from hundreds of different authors.
- Under the Macmillan Publishing Group is Farrar, Straus and Giroux, MCD, Picador, North Point Press, Hill and Wang, Henry Holt and Company, St. Martin's Press, and Tor/Forge. It also includes their Children's Publishing Group. Authors under Macmillan Publishing include David McCullough, Nora Roberts, and Colson Whitehead.

#### How long will this suspension last?

• We do not have an end date right now. Should Macmillan cancel its embargo, we will immediately lift suspension.

#### • Why don't you at least take the single eBook Macmillan is offering?

- We believe everyone deserves equal access to books and information. In our view, Macmillan's
  policy means that only those who can and will pay for access deserve it. That is why we believe we
  have to take this action.
- O Additionally, your chances of getting access to a single copy in the first two months are slim at best. We have hundreds of patrons who place holds on the most popular eBooks. Everyone can hold or check out an eBook for up to 14 days. By the time you get to the top of a queue, odds are it will have been several months already.
- o We understand that this is frustrating. We know this decision will not please everyone, but we firmly believe that this suspension is the best way we can support our eBook readers and ensure that libraries have equal access to digital materials.
